BOTY: "Yesterday, Melanie Mowrer and Kathy Walczak conducted a reading circle for ASG members in the Learning Center. Melanie and Kathy received Leave a Legacy funds from ASG for the reading circle project which consists of bi-monthly sessions of reading stories from the 2017-18 Book of the Year. The objective of the reading circles was to inspire a love for reading for pleasure. The ASG group had lunch and read one of the stories from the book. After the reading, the students participated in a lively discussion on the theme of political activism and pledged their support to the Book of the Year program." (from Kathy Walczak)

BSI 2.0/Student Success for Basic Skills

- BSI changed to SSBS with new funding formula
- We'll be notified of augmented allocation this week
  - o 50% on percentage of BOGFW students from 2014-15 cohort who enrolled in a below college-level course, and subsequently completed a college-level course in the same subject within one or two years. For English and ESL, the transfer level course considered is Freshman Composition. For math, transfer-level courses and onelevel-below transfer courses are counted. For reading, one-level below transfer courses are counted.
  - o 25% on percentage of BOGFW students from 2014-15 cohort.
- Total BSI allocation for CCCs this year will be approximately \$48 million.
   (previously = \$19 million)
- The remaining 25% of total BSI funds (about \$12 million) will be allocated through a certification process that will be due late November or early December.
- Certification process will require college reporting of how much of its 2014-14 basic skills FTES used practices and principles from the BSSOT Program, e.g. multiple measures assessment, direct placement into transferable English and math, acceleration of 2-3 course sequences.
