A limited number of scholarships are available to students in good academic standing and have extreme financial need that may not have access to traditional funding sources. Funds are available for unpaid registration fees and/or un-purchased books.

Who May Apply:

Santa Ana College students

- Currently enrolled at SAC
- Are in good academic standing
- Have extreme financial need
- Have a recommendation from a SAC faculty member

How to Apply:

- Pick up a Rolling Scholarship Application from the Scholarship Program in the Administration Building, room S-201.
- Complete the application
- Include a one page statement with the following information
 - major
 - educational goal
 - career goal
 - financial need situation
 - specific amount needed for the semester
- Attach supporting documentation with your financial information page.
- Obtain a signature from a member of Santa Ana College Faculty as a recommendation for the Student Services Rolling Scholarship attesting to financial need and academic standing.

Where to apply:

Return completed application to the Scholarship Program, room S-201.

Make an appointment to review your scholarship request.

Applications should to be submitted during walk-in hours so that you may make an appointment.

To complete the application process for the Student Services Rolling Scholarship, turn in your application to the Scholarship Program, room S-201 and make an appointment for application review.

The Scholarship Program has limited walk in hours. You may make an appointment during Walk-in Hours.
