- a. AB 705 Placement and Outcomes -Tyler Nguyen
 - i. AB 705 requires California community colleges to maximize the probability that a student will enter and complete transfer-level coursework in English and math within a one-year timeframe. Colleges must place students into English and math courses using one or more of the following:
 - 1. High school coursework 2. High school grades 3. High school grade point average
 - ii. Under the new law, the students cannot be denied entry into a transferlevel math and English class unless the college can prove that:
 - 1. The student is highly unlikely to succeed in the transfer-level course.
 - 2. Enrolling in a pre-transfer-level course will improve the student's likelihood of completing transfer-level courses in one year
 - iii. Implementation of AB705 is important for students because they are often held back by the placement test, becoming stuck in sequences that statistically ensure failure to transfer to higher institutions.
 - iv. All community colleges are required to be in compliance with AB 705 no later than fall of 2019.
