Report from Curriculum and Instruction Council

-On Curricunet, the "course objectives" field has been made available on the Course Outline of Record (COR). C&I has requested that council members advise faculty to begin to include the course objectives on the COR from this point forward. Once course objectives have been documented on the COR, the course SLOs can be saved to Department/Division folders on the Public H:drive as are the SLO assessments. The SLOs would no longer need to be on the COR.

- -SLOs STILL need to be on your course syllabi.
- -Monica Porter has developed a checklist to use when reviewing and writing Course Outlines of Record. Division Curriculum members will review for input (see handout).
- -If you are submitting an AA-T (this year until Jan 14) then every course which has a corresponding C-ID must have been submitted for C-ID approval.
- -If you are submitting an AA-T (next year) then every course which has a corresponding C-ID must have been approved for C-ID. If you are revising a course or writing a new course for C-ID purposes, you should look at C-ID descriptors and make sure your objectives match them.
- -Monica Porter will be working with the C&I Chair @ SCC to develop an implementation plan regarding the use of content review alone to validate prerequisites for courses, especially when prerequisites exist outside of the discipline. The RSCCD policy has been to use content review & statistical data for this validation. The implementation plan will ultimately be presented to the Board of Trustees for approval for a change to the current policy.
- -SLOs need to be accessible to the public. Suggestions included placing course SLOs on individual dept websites. Other suggestions are welcomed.
- -Monica is currently updating the SAC's Curriculum & Instruction Handbook. Hopefully, this handbook will be ready by the end of the semester.
- -There may be a change to the dates of submission of curriculum by faculty for review by the technical committee and the C&I council members. In an effort to provide the council with adequate time for review of all course outlines prior to approval, a change is recommended.
- -CurricuNET META will hopefully roll-over all of the information we now have in CurricuNET.
