Hello Everyone,

Exciting times are ahead! We move into the fall 2013 semester with the promise of increased enrollments in our classes, and the continued beautification of our campus perimeter! I love the start of each semester, especially when I stop on the mall to ask students how they are doing. Whether they are first time students or continuing there is an element of excitement and anxiety in their response!

The Accreditation Oversight Committee (Institutional Effectiveness Committee) will be working diligently to ensure that you all have what you need to complete the writing and prepare your section of our Self-Evaluation report.

Please save the date, September 6, 2013 from 9:00-12:00 for the first of several meetings during the fall 2013 semester. We will provide you with more details about the location of the September 6, meeting next week. At our September 6, meeting we will review the timeline matrix, Teams can present the progress they have made on data gathering, review the writing style sheet provided by ACCJC, review the SAC Accreditation website, and discuss any concerns you have about the process, so far.
