 - B. Accreditation Monica Zarske

- i. Shared that on Friday October 9, 2020 Dr. Catherine Webb- ACCJC Accreditation Liaison will be meeting with SAC to get an overview of best practices. Registration is open through Professional Development. 10am-12pm. Writing retreat will be hosted as a part of the training.
- ii. Dr. Jeffrey Lamb-Shared that quality focus essay should be a dialog for future self- What do we want to focus on? Guided Pathway and Equity should be reflected in the essay. Essay should speak to innovation at our College-Executive summary on Guided Pathways, potential of program maps. Intentional on where we want to be in 2-3 years.
- iii. Dr. Lamb- Shared that after Accreditation, there will have been lessons learned for Mid-Term report and should begin looking to plan for next cycle. Ideally, we should not let the process become a distant memory.
- iv. ISER is to evaluate, reflect and amplify success.

C. Program Review – Jaki King

- v. Dr. Lamb-Thoughts on Nuventive integration-Any feedback on preferences and layout?
 - 1. Jaki King: There are some parts we are still working with and getting used to Ex: Front interface
- vi. Jaki mentioned faculty and staff will be using this platform for a while and we are hoping they get comfortable and use to the interface.
- vii. Dr. Jarek Janio-Links can be added to Nuventive related to specific topic. Extensive menu available for clarification. Customizable help buttons in case a specific item is more difficult to understand.
- viii. Dr. Jeffrey Lamb- Recommended a Nuventive layout Presentation to committee to demonstrate the process and integration-November 4
- ix. Jaki King- Recommended to begin trainings and workshops in Spring for faculty
