IV.a. Accreditation Report

The next accreditation is scheduled for 2022.

J. Lamb mentioned that assessment is linked with Curriculum. Assessment needs to be used as a valuable tool to evaluate the work we do and to ensure we do not find ourselves facing sanctions.

IV.b. Articulation Report

P. Canzona stated that policy changes for CSU GE or IGETC need to be submitted to the Curriculum Office by September 26th to ensure a December submission to UC and CSU.

IV.c. CurricUNET Update

Password and login information to test META will once again be e-mailed to all CIC members. CIC membership was asked to test the META system to ensure bugs are found. META will be rolled out Spring 2019. Professional development workshops will be offered to all faculty in January.

IV.d. Guided Pathways

K. Patterson reported that META majors will be rolled out soon. Much work has been done behind the scenes so stay tuned.

IV.e. Curriculum Institute

V. AB 705 – M. Aguilar Beltran

M. Aguilar-Beltran presented on the framework for AB 705. She explained that high school performance and qualitative data will be used, commencing Spring 2019, to assess students who apply by November 1, 2018. Standardized testing will not be used to place students. Programs and degrees that have Reading or below-transfer-level English or Math need to review those requirements.

M. Aguilar-Beltran further stated that it is imperative that we look at the data as the burden of proof is on the institution and not on the student to show that the student will not be successful in transfer-level English or Math, if placing them in classes below transfer level.

VI. Course Objectives vs. Course Content – Review

B. Sos provided an overview of the Course Outline of Record (COR) and explained the differences between the course objectives and the course content. He spoke of the rigor and intensity necessary to obtain articulation, core components and faculty academic freedom.

B. Sos provided examples of how course objectives lead to the course's Student Learning Outcomes and defined the two by differentiating them. He also stressed the importance of following processes, being specific with enough details and looking at all curriculum with a fine-toothed-comb.

VII. OTHER

As courses are presented, representatives should indicate whether courses need to be considered for inclusion in future addendums. Courses geared towards CSU and UC transferability will not be entertained for the addendum at this time. Discussion followed.
