IV.c. CurricUNET Update

K. Patterson reported that Career and Academic Pathways for Success (CAPPS) is being considered as the branding name of Meta Majors.

J. Lamb stated that the banding name and acronym are being reconsidered as they are too close to Career Advanced Placement (CAP). He also mentioned that mapping and academic advising were merging to become one team.

V. PREREQUISITE PROCESS – B. Sos

B. Sos provided an overview of the prerequisite process, which included requirements for establishing prerequisites, co-requisites and advisories. He expressed the importance of on-going validation of requisites. Advisories also need to fall in line with the current AB 705 guidelines.

B. Sos stressed that procedures and policies for requisites need to be in place and reviewed on a regular basis, as impact to other programs is crucial. Discussion followed.

VI. OTHER

K. Patterson expressed concerns with shared curriculum processes and the impact course and program changes has on programs at both campuses.

B. Sos stressed the importance of communicating with SCC faculty as it relates to shared curriculum. At this time, department chairs and division CIC representatives are expected to monitor changes and communicate between campuses. Discussion followed.
