Meeting was called to order at 2:01 by B. Sos, CIC Chair.

I. PUBLIC COMMENTS

C. Coyne expressed her gratitude to B. Sos for his service as the Curriculum and Instruction Council (CIC) Chair for the past several years.

M. Grant thanked the members of the council for their patience and engagement at the May 3rd CIC Meeting. She articulated her appreciation of the discussion and the challenges that everyone has faced during these unprecedented times. She further mentioned that the discussion provided an opportunity to begin in depth curricular discussions as it relates to credit and noncredit courses.

K. Patterson stated her gratitude to B. Sos as he wrapped up his tenure as the CIC Chair.

IV. CURRICULUM and INSTRUCTION COUNCIL (CIC) HANDBOOK

a. First Read: Mission Statement

J. Tolentino mentioned that no negative feedback has been received as it relates to the Mission Statement.

b. First Read: Membership

- J. Tolentino stated that controversial comments have been expressed with the proposed membership. He reported that it has been mentioned that the Academic Senate is the body with the authority to define CIC membership. He also said that adding a second Dean has been controversial.
- B. Sos mentioned that it appears more collaboration and dialogue is still needed; thus, he asked J. Tolentino to continue heading this committee.
- J. Tolentino thanked CIC for the opportunity to head the Mission Statement and Membership part of the CIC Handbook.

Discussion ensued.

c. First Read: Roles and Responsibilities

- R. Castillo explained that Membership determines who will be added in the Roles and Responsibilities. He said that descriptions were added for Enrollment Services and Student Representatives as well as Articulation Officer and Distance Education Coordinator.
- M. Grant mentioned that this committee is waiting for the Membership to provide a final list as it important to ensure that all roles are identified and clearly defined.
- K. Patterson asked for the Honors Program Coordinator to be added to the Roles and Responsibilities. This position does not need to be a member of the CIC Committee; however, it is important that the position be incorporated in the Handbook to ensure collaboration and dialogue happens prior to faculty proposing new, revisions or deletions of honors courses. She also stated that formalizing the process will ensure a smooth review by UCLA.
- K. Patterson requested that it be outlined in the Roles and Responsibilities that the CIC Chair, Articulation Officer, Curriculum Specialists, Vice President of Academic Affairs or Dean of Academic Affairs be expected to attend the Curriculum Institute every year. She also stated that monies to pay for attendance to the Curriculum Institute be allocated every year, as part of the Academic Affairs budget, and Conference Requests processed without any need for any of those individuals to request monies from Professional Development or need to complete their own Conference Requests. This should be automatic. Other faculty wishing to attend may go through the Professional Development conference request process.

d. Second Read: Cross-Listed Courses and General Education Policy

P. Canzona reiterated that the policy will allow any cross-listed course to be automatically approved in Plan A where the original course is approved without additional scrutiny.

V. DISCUSSION: TRANSFORMATIVE CURRICULUM REDESIGN

S. Clark spoke about Module 7: Equity-Minded Curriculum Redesign FAQs responses. She emphasized that the Learning and Engagement Team is incorporating the Course Outline of Record (COR) evaluation as part of the equity-minded professional practices. She further stated that the process will contextualize into a potential check-list for participants to use when reviewing their current discipline-specified CORs. The Team hopes that participants will assess language and identify gaps where equity-minded engagement may be added to their course content.

M. Aguilar-Beltran requested volunteers from CIC to partner with the Learning and Engagement Team to verify Module 7 details so that the module would align with the current CIC processes and timelines. C. Coyne and C. Emley volunteered to be part of the partnership committee.

She mentioned that the Learning and Engagement Team has received endorsement from the Academic Senate.

Discussion followed.

VI. PRESENTATION: OPEN EDUCATIONAL RESOURCES (OER)

A. Knight provided clarification of what OER means and where to locate publication dates. She shared and reviewed a link to the Open Textbook Library as well as provided an explanation of Open Iicenses. She provided a brief synopsis of professional resources, copyrighted materials and YouTube materials that may be copyrighted but can be used if intended for teaching and/or educational purposes.

Discussion followed.

VII. SECOND READ: CTE PROGRAM REVIEW PROCESS

F. Ortiz iterated that currently, there is no process to review Career Technical Education (CTE) programs. He also stated that CTE programs are to be reviewed every two years, and this process will provide a guide to keep the college in compliance.

M. Grant stated that we are in an accreditation cycle and having a process, via the curricular development, addresses all the details to ensure compliance with the Title 5 Educational Code and the Program and Course Approval Handbook (PCAH).
