### V. Catalog Work Group

D. Dumon shared her concerns with the order of the academic programs in the current catalog. She mentioned that related Associate Degrees and Certificate of Achievements were in different pages rather than next to each other. She said that this translates to students believing that Certificates of Achievements are not available. D. Peraza shared that the Digital Publishing AA is on page 85 and Digital Publishing CA is on page 88, in the current catalog, as an example.

D. Dumon asked for volunteers to form a catalog task force to organize the catalog.

Discussion followed.

# VI. Curriculum Proposal Review – Best Practices

C. Coyne shared the number of credit and noncredit courses and programs reviewed by CIC during the 2021 calendar year. She expressed interest in finding a method to ensure all proposals have full reviews by multiple CIC members, becoming more efficient with reviewing proposals.

C. Coyne explained the conditions of enrollment tab within META. She described the requirements needed for each requisite and requested that faculty update any historical versions of courses to active or approved.

C. Coyne reviewed the information needed in the course materials tab in META, which included requirements from the UC Transfer Course Agreement, Guiding Notes for GE Course Reviewers (CSU-GE, and IGETC) as well as IGETC standards.

C. Coyne specified that outside assignments need to be included in the Reading and Writing textboxes and not under other assignments.

## VII. Reports and Announcements

## a. Academic Senate By-laws Update - Elections

C. Coyne stated that the Academic Senate updated their By-laws. She explained that Curriculum Chair position will no longer be an appointed position but a position that is elected by Academic Senate Officers. C. Coyne shared details of the CIC Chair eligibility criteria, the terms of office, Lecture Hour Equivalency (LHE) compensation and her current and future role in CIC.

Discussion ensued.

### b. Department Reorganization Taskforce – Call for Participation

C. Coyne mentioned that a process will be put in place for reorganizations. Anyone interested in joining the task force should contact her.

### c. CIC Meetings

C. Coyne stated that as the Governor's exemptions to the Brown Act expire at the end of March, CIC will resume in-person meetings. Arrangements have been made for subsequent meetings to be held in larger spaces to allow social distancing. Two of the three remaining meetings will be held at SAC in the Cesar Chavez Building and the Johnson Center. She further mentioned that as our colleagues at Continuing Education, prior to Covid, regularly made the "trek" to the SAC campus for meeting. In an effort to build stronger connections with our non-credit counterparts, CEC has graciously offered to host the May 2<sup>nd</sup> Meeting.

C. Coyne commented that the Board of Trustees will be discussing the Adoption of Resolution No. 22-12 Authorizing Continued Used of Remote Teleconferencing Provisions Pursuant to AB 361 and Government Code Section 54953. Members expressed support to continue teleconference meetings through the end

of the semester. J. Lamb will contact legal counsel and provide his findings to C. Coyne before next meeting.

# d. Assembly Bill 928 - Input Requested

C. Coyne reminded members of the survey sent several weeks ago seeking input on the legislation that was passed to create a common (singular) GE pattern. She stated that the results will go to the Intersegmental Committee of Academic Senates (ICAS) which is the body identified in the legislation that will establish a singular lower-division general education pathway that will meet the academic requirements necessary for transfer admission to the California State University and University of California system. She encouraged members to share their thoughts and/or concerns by completing the survey.

## VIII. Other

C. Coyne mentioned that academic freedom is essential to student-centered equity and anti-racism work in the California Community Colleges as identified in the California Community Colleges Chancellor's Office Call to Action and the ASCCC Mission and Strategic Plan. She further stated that the connection between academic freedom and equity is fundamental. Without the rights of faculty to speak, research, and pursue diverse ideas, equity is not possible. C. Coyne also said that academic freedom allows faculty to academically challenge racist ideology and structures in the context of their subject matter expertise. Thus, she asked faculty to attend the Equity and Anti-racism in Academic Freedom Workshop scheduled for April 25<sup>th</sup> from 2:00 p.m. - 3:00 p.m. You may register for the free workshop by clicking on this link: https://us02web.zoom.us/meeting/register/tZcof-iggjIrG92IbNrkLADDT-a75MW8V15a
