VI. Substitutions for Associate Degree for Transfer (AD-T)

P. Canzona referenced the Course Substitutions and Reciprocity, Policy and Procedures found within the college catalog where she explained which courses may be used for substitution in Associate Degrees for Transfer (AD-Ts). She stated that AD-Ts are more regulated than local Associate Degrees; thus, when a course substitution is approved, the courses must be largely the same. She further stated that she is always available to answer questions about specific scenarios. Substitutions of courses from other California Community Colleges (CCCs) or California State Universities (CSUs) made by matching C-ID numbers are done automatically and do not go through a petition process.

VII. New Department for Child Development Apprenticeship

C. Lamourelle provided a synopsis of SAC and SCC's joint effort to provide a Child Development Apprenticeship program for Child Development and Education students. She requested the creation of a new department code (APCD – Apprenticeship Child Development) within Child Development to proceed with the creation of curriculum. She also mentioned that SAC's Child Development curriculum will be aligned with SCC's curriculum.

C. Coyne stated that she will be presenting a resolution to the Academic Senate, in coordination with SCC, in support of the formation of the new department.

Discussion followed.

VIII. Recommendation for Exception to Curriculum Process for Communication Studies 101

C. Coyne explained that there are times when faculty ask for exceptions to the curriculum process. The exceptions are considered on a one-to-one basis to ensure the integrity is maintained. She stated that Communication Studies (CMST) 101 had been approved by CIC on February 13, 2023. Since the approval, new suggestions have been made by the Articulation Officer to modify courses, not currently approved by UC, with content for potential University of California (UC) approval. Since CMST 101 has not been approved by the Board of Trustees (BOT), the recommendation to CIC is to remove approval status in META and make the course available for Communications faculty to resubmit with the modifications with content required by UC.

Discussion ensued.

A motion was made to remove the approved designation in META and make the course available for faculty to make modifications to CMST 101 to meet IGETC standards.
