V. Accessibility Updates

K. Taylor addressed the council to highlight the core principles of the Disabled Student Programs and Services (DSPS). She discussed the importance of collaboration in supporting all students, both those registered with DSPS and those who are not. K. Taylor emphasized the DSPS philosophy, its integration with curriculum, and the key issues affecting students, with a focus on human access and addressing the natural supports that enhance student success.

K. Taylor explained that Assembly Bill (AB) 1885 introduces a Student Success Completion Grant aimed at enhancing financial aid support for students. Commencing with the 2025–2026 academic year, students enrolled in 9 or more units. and considered full-time based on their DSPS Academic Accommodation Plan, will be eligible to receive \$1,298 per semester, or the quarterly equivalent, as outlined in AB 1885.

K. Taylor informed the council that under Assembly Bill (AB) 2821, Postsecondary Education: Students with Disabilities, all school districts will be required to implement Disability Access and Compliance Training (DACT) for all employees, including management, faculty, and classified professionals, starting in the 2026–2027 academic year.

A discussion followed, during which faculty members advocated for compensating students for their time and contributions to the development of DACT. Questions were also raised about whether the Professional Development (PD) coordinators had been engaged to support the structure of DACT, and if potential funding was available to support faculty participation.

VI. Chair's Report

A. CCN Division Leads

D. Peraza announced that the Curriculum and Instructional Council (CIC) is seeking faculty division leads and faculty members to support and contribute to Phase IIB of the Common Course Numbering (CCN) initiative, with completion targeted for Fall 2025. Division leads will receive 1.5 LHE as compensation, while faculty working on CCN templates will be compensated with 0.5 LHE. D. Peraza will provide the necessary training. He asked CIC members to help identify interested faculty.

Faculty interested in contributing to the statewide templates should submit their nominations to C. Coyne, Academic Senate President.

K. Robinson reported that CIC approved Administrative Regulation (AR) 4235, Credit for Prior Learning, at its March 10, 2025, meeting. SCC is revisiting the regulation at its CIC committee meeting on April 21st to consider additional modifications. The proposed changes focus on incorporating apprenticeship and work-based learning.

M. Morin distributed the updated Administrative Regulation (AR) with the proposed revisions via email. K. Robinson requested that committee members consult with their respective constituencies and bring feedback to the next CIC meeting.

Discussion ensued.

K. Robinson gave a brief update on program maps and encouraged faculty to connect with M. Macintyre, who is leading the initiative.

VII. First Read

A. Curriculum Process Review

K. Robinson asked committee members whether they had received feedback from their constituents regarding the potential pause on quadrennial course reviews. She clarified that Career Education courses, along with new and revised courses, would not be affected by the pause. The proposed hold aims to ensure that upcoming initiatives from the Chancellor's Office are fully integrated into the Course Outline of Record (COR), providing clear guidance and preventing faculty from having to revise their quadrennials again to accommodate future updates.

Discussion ensued.
