## V. Chair's Report

K. Robinson introduced a discussion on the prerequisite language for upper-level general education courses in the Bachelor's Degree Programs (BDPs). She explained that the current SAC policy requires students to be admitted specifically to a BDP at SAC to enroll in these courses. However, she noted that other colleges within the system allow students enrolled in any BDP, regardless of campus, to take such courses. P. Canzona confirmed that this practice is occurring at other institutions. The group engaged in a discussion on the topic, during which J. Lamb suggested that adopting more flexible language could increase course offerings and access for students. Members were encouraged to consult with their divisions to determine the most appropriate policy or language moving forward.

K. Robinson explained that courses numbered 098 and 198 have traditionally served as shell courses for experimental offerings. However, these course templates are not approved by the Chancellor's Office and include only minimal, vague information. She noted that experimental courses are generally discouraged, as they require the same approval time through CIC as regular courses but can only be offered for two semesters. She encouraged faculty currently using 098 and 198 courses to evaluate whether they are still necessary.

K. Robinson reminded faculty to complete all fields in the Program Course Requirements tab when adding courses to a program. Filling out this information ensures that currlQunet can automatically generate the program narrative, which will replace the current paper-based narrative form.

## VI. Discussion Items

## A. Course Outline of Record (COR) and Course Objectives Numbering in META

A discussion took place regarding the format of course objectives on the Course Outline of Record (COR) in CurrlQunet, specifically whether they should be presented as bullet points or numbered items. D. Peraza noted that the Common Course Numbering (CCN) system requires objectives to be numbered, and the state is moving toward full alignment with the CCN framework. K. Robinson asked members to consult with their divisions on this issue and report back at the next meeting.

## B. FARSCCD Contract Process and Criteria for Additional Lab Rate

K. Robinson noted that the new FARSCCD contract includes a provision for additional LHE for courses that require extensive writing assignments or lab preparation. The CIC will collaborate with SCC's CIC to develop criteria for this designation. Under the new agreement, faculty may request that a course be considered for the additional LHE.

## C. Standardized Attendance Accounting and Hanging Hours

M. Morin introduced the new standardized student attendance accounting method, outlining the changes in the updated formula and providing examples of various unit and hour configurations. He also shared a spreadsheet listing the courses impacted by these changes with the committee. J. Lamb emphasized that the evaluation of courses with "hanging hours" should prioritize student needs and positive outcomes. He encouraged a thoughtful approach that aligns with core values, promotes reflection, and ensures decisions are made with the students' best interests in mind.

#### D. CIP Codes Update

K. Robinson and R. Vazquez noted that COCI now requires CIP codes for all course submissions. R. Vazquez added that several crosswalk documents are available on the curriculum website to assist faculty in aligning their TOP codes with the appropriate CIP codes.

## VII. Other

R. Vazquez mentioned that the ASCCC will hold its Fall Regional Meeting at Long Beach City College on November 1st. The event is free, and all council members are encouraged to attend. If you're interested in participating, please reach out to the curriculum office.
