She also engaged faculty in exploring the deeper meaning of stereotypes, prejudice and discrimination, oppression and privilege and fabric of oppression. She asked council members to examine their behavior towards dual attitudes, microaggression and intent  $\neq$ Impact. She articulated how the concepts relate to curriculum.

C. Umali Kopp asked that she be invited back at a future time to ensure more dialogue was performed between all council members.
