IV. READING PROFICIENCY INFORMATION

B. Sos stated that he wanted to ensure that the Reading Proficiency statement submitted to the Board of Trustees for approval was as clear as possible and easy for students to understand.

B. Sos stated that SCC faculty have voiced concerns to the Academic Senate and the District Curriculum and Instruction Council (DCIC). The concerns include a desire for more collaboration on the topic and interest in seeing longitudinal data in support of the decision. He also mentioned that SCC faculty did not support the direction that SAC CIC supported as it operationally eliminates the reading proficiency requirement; because English 101 is mandated for the writing proficiency. SCC faculty believes that both colleges should be as similar as possible. They requested that future policy changes to the Associate Degree be collaborative effort.

P. Canzona mentioned that current board policy allows each college to determine how proficiencies, such as Reading, are met. SAC and SCC are allowed to meet the same proficiency in different ways, as is currently the case with the Math proficiency.

V. EMERGENCY DISTANCE EDUCATION ADDENDUM DISCUSSION

C. Kushida reported that the Distance Education (DE) Emergency Blanket Report is due May 20th for summer courses. She stated that a Fall 2020 plan is needed for courses without approved Distance Education Forms. In addition, all courses must have DE approval by December 30th.

C. Kushida explained that the Fully Online with Mutual Agreement (FOMA) document presented to the council is a way to meet the plan and provide courses with an emergency DE form to be used only during emergency situations such as Covid-19. The form is prepopulated. J. Lamb has stated that he will provide a staff member to the Curriculum Office (similar to the 48 to 54-hour divisor work) to complete the task if it cannot be handled by META in a timely manner. Discussion ensued.

Faculty will submit modifications to FOMA via Curriculum Office. Amendments will be presented at the next CIC Meeting.

CIC membership supported the concept of two (2) DE forms – Traditional DE and FOMA.

V.a. Accreditation Report

F. Ortiz mentioned that the Accreditation Committee Workshop scheduled on April 23rd was well attended. He further stated that committees are busy gathering evidence and identifying where resources are needed. He also explained that Monica Zarske and Young Kim are identifying websites that need to be updated to be in compliance.

The Accreditation Committee meets every other week. Next meeting is scheduled for May 8th. Committee needs evidence-collectors and faculty participation.

V.b. Articulation Report

P. Canzona will email faculty all IGETC and CSU-GE approved/denied proposals for 2020-2021. She will also update the 2020-2021 college catalog.

V.c. currlQūnet META Update

R. Vazquez provided a synopsis of the challenges with the catalog. She also mentioned that once the catalog is completed, our focus will revert back to finalizing many of the requests submitted since the transition.

V.d. Guided Pathways (GP)

F. Ortiz reported on the upcoming GP events. Success Summit will be held on May 8th. GP Forum: Program Map is scheduled for May 13th. A late released GP-themed 2020-2021 catalog is being considered.
