I. PUBLIC COMMENTS

S. Clark informed the committee that she had been reassigned to the Digital Media Department. She stated that administration requested that she receive a recommendation from the Senate and CIC Council on curriculum alignment that encompasses Digital Media Arts and Graphic Design Programs. She respectfully requested that CIC consider the proposal she presented in February 2020. She further stated that she is hoping to have the curriculum changes done to ensure they are captured in the 2021-2022 college catalog.

S. Clark stated that she is hoping for the matter to be transparent and public.

M. Taylor commented that he is the Digital Media Department Chair. S. Clark is part of his department and he was unaware of any discussions related to curriculum. He further requested that S. Clark be included in any Art Department discussion as she is the discipline expert. He also requested transparency.

C. Pierce requested that Digital Media Proposal for Digital Media Curriculum Alignment be an item added to this agenda. The request was not granted.

B. Sos stated that he was providing the Art Department with an opportunity to present to the council as the opportunity to present was also afforded to S. Clark. Item number 7 on the agenda is being tabled. Item #7, Art Department Curriculum, will be added to the next agenda where dialogue may occur. B. Sos mentioned that further discussion on this subject will occur on Wednesday with the Academic Senate President.

J. Kennedy expressed his gratitude to the committee for considering the Correspondence Education Addendum on the agenda. He reassured the committee that Correspondence Education would not be institutionalized. He explained that this is a response to the current Covid-19 situation we are facing and need to provide educational opportunities to the Inmate Education Program.

IV. DISCUSSION: CORRESPONDENCE EDUCATION ADDENDUM

B. Sos explained that SAC does not have a current policy that pertains to Correspondence Education (CE). He further stated that as we continue in the pandemic, there is an apparent need for CE within the Inmate Program. B. Sos requested that members relay the information D. Khalid will be providing to their respective constituents so that there is clear communication and so that CIC members can vote on the issue of CE at the next CIC meeting.

D. Khalid expressed gratitude at the opportunity to speak on behalf of Correspondence Education. She described the need for this methodology of teaching for the Inmate Program and the guidleines set forth by the Santa Ana Police Department (SAPD) and the federal prisons. CE will be used to address the needs of students in the jail system but will only be used during the unprecedented pandemic we are currently facing. She further explained that Distance Education, as we know it, is not possible within the SAPD facilities. She requested support from this body and stated that the needs of the inmate program students is at the forefront of the request.

D. Khalid presented the CE addendum document that the Continuing Education faculty would like adopt. She reiterated that this is a temporary solution.

Discussion followed.

V. DISCUSSION: CAREER EDUCATION PROPOSAL PROCESS

B. Sos cited language found in Education Code, Section 78016 where it states that "every vocational or occupational training program offered by a community college district shall be reviewed every two years." As such, he mentioned that faculty need to identify when Career Education (CE) program reviews, within their respective disciplines, are due. As part of the review process, current Labor Market Information (LMI) is required.

B. Sos stated that a formalized process will need to be created and vetted through the Academic Senate.

Discussion ensued.

VI. **DISCUSSION: MIS DATA ELEMENTS PROCESS**

B. Sos informed the committee that Management Information Systems (MIS) data elements are used for tracking courses and programs. These elements are also essential to qualify for certain grants, including Financial Aid. He provided a brief synopsis on past practice when coding courses and programs. He asked who the coding responsibility, specifically TOP and SAM codes, should fall to (faculty or division curriculum secretaries). He further indicated that a process needs to be in place to avoid confusion.

B. Sos stated that some data elements have been mismatched; therefore, issues have been encountered when submitting to the Chancellors Office Curriculum Inventory (COCI). He expressed the importance of ensuring that MIS data element CB03 – Course Top Code, CB04 – Course Credit Status, CB05 – Course Transfer Status, and CB09 – Course SAM Priority Code be coded correctly in courses.

B. Sos requested that members take the information provided back to their respective constituents and that feedback be provided at the next meeting.

Discussion ensued.

F. Ortiz reported that SAC is coordinating with ACCJC personnel to provide training on best ways to proceed with the writing process. He mentioned that the goal is to have a first draft of the report completed by the end of Fall. Standard Teams continue to meet. He expressed his gratitude to all who are participating in the Accreditation process.

B. Sos stated that the spreadsheet identifying courses that will have a Fully Online with Mutual Agreement (FOMA) will be submitted to Governet by the end of the week. Prior to submission, he will send the spreadsheet to faculty once again to ensure that the information is correct. He explained that the FOMA will be done behind the scenes. A report will be requested from Governet to ensure that the work has been completed.

VIII.d. GUIDED PATHWAYS (GP)

K. Patterson reported that GP is starting their exploration months commencing with September, which is Creating our World, followed by People, Ideas and Culture in October, and concluding with Future Educators in November. She also stated that workshops and events will be held every month. Working Success Teams have been formed.
