IV. ACTION: ART/DIGITAL MEDIA CURRICULUM

P. Marquez and D. Hostetter presented their argument to retain the Graphic Design Degree within the Art Department. They stated that the Art Department has made major concessions by agreeing to move and cross-list numerous Art classes to the Digital Media Department, and they feel they do a better job at transferring students to four-year institutions.

S. Clark argued that zero (0) to four (4) students have earned the Graphic Design Degree. She stated concerns with material fees and the Art Department's refusal to review curriculum that supports updating of courses. She named former student graphic designers who support the move of the Graphic Design Degree to Digital Media. She further stated that the move would provide improvements in branding and skills.

Discussion ensued.

V. ACTION: CREDIT FOR PRIOR LEARNING (Second Read)

B. Sos presented Administrative Regulation (AR) 4235, Credit for Prior Learning, and focused on the proposed changes. He stated that SCC had provisionally approved the presented changes; however, SCC's CIC Chair will make appropriate changes approved by SAC CIC.

P. Canzona suggested that the Advanced Placement Credit heading be changed to Credit by Exam.

B. Sos will provide SAC's CIC feedback to SCC and will move the AR forward to the respective Academic Senates. He further mentioned that the catalog will be updated to reflect updates. Courses that fall in this category should be clearly identified, and a specific section should be created within the catalog.

VI. DISCUSSION: FULLY ONLINE by MUTUAL AGREEMENT (FOMA) DEFINITION

He presented a document that outlined details, expectations of course delivery, mode of instruction training and the most appropriate class scheduling recommendations. He stated that the form does not need to be called Fully Online by Mutual Agreement. The name can be changed. An alternative name could be Remote Instruction Certification (RIC). He also discussed SCC's definition of their Emergency Only Definition for DEA.

B. Sos asked CIC members to share the document with their respective constituents and provide feedback at next meeting.
