- a. Budget and Integrated Planning update: Student Equity, Basic Skills Initiative, and Student Success and Support Program
 - 1. Have between now and Fall 17 semester to integrate plans.
 - 2. Opportunity to spotlight SAC work that has had positive results
 - 3. Basic Skills budget could triple as of next year
 - 4. Forming a team as part of the planning process
 - 5. Goal is to have rough draft plan by Summer
 - 6. Will need support from Research

 - 1. Steps 1 & 2 of the 11 implementations steps based on the Chancellor's Office have been completed as well as part of Step 5.
 - 2. Task force will be meeting May 3 to discuss the one time \$15,000 funding (Step 3).
 - 3. District is still scheduled to adopt Spring 2018 for new Fall 2018 students. Maria has requested that we stay on schedule or are delayed by no more than one semester.

 - 3. Delivery date of the Academic Computing Center is 5 weeks away (June 15 is the target installation date)
 - 4. A-104 will be available for computer use but will also be available for class use.

 - 3. Soft Opening Fall 17 with at least 11 classrooms & new equipment
 - 4. Integration of credit and non-credit programs at this site. May also surve as incubator for accelerated completion.
