**LEARNING OBJECTIVES:** Students who successfully complete this course will be able to: 1)Understand contract law, including formation, defenses, breach and remedies; 2) Apply those concepts to a variety of documents, including contracts governing business organizations, real property; family law and estate planning; and 3) select, edit and customize formbook and computerized forms.

## **GRADING/ASSESSMENT METHODS:**

\*Participation= 20% Portfolio = 30% Midterm #1= 15% Midterm #2 = 15% Final Exam = 20% Total 100%

\*Participation is evaluated through in-class contribution, the presentation, and discussion board.

Extra Credit may be offered at the instructors discretion. Your semester grade will be based on what percentage of total points you earned as compared to the total points that were offered. I will "scale" the grade, at my discretion, once all grades have been entered.

**GRADING RATIONALE/GRADING POLICY:** The grading scale should conform to the following:

A = 90% and above as compared to peers on tests, quizzes and assignments. Two or fewer classes missed with few or no tardies. Class participation is insightful and reflects students review of Blackboard materials for the week and an interest in the subject matter.

B = 80% - 89% as compared to peers on tests, quizzes and assignments. Three or fewer classes missed with few or no tardies. Class participation is thoughtful and reflects students review of Blackboard materials for the week and an interest in the subject matter.

C = 70% - 79% as compared to peers on tests, quizzes and assignments. Four or fewer classes missed with few or no tardies. Some class participation and general interest in the subject matter.
